THE HAROLD HANSEN MEMORIAL LAKE TAHOE CHALLENGE TOUR

We have chosen to honor our dear departed friend, Harold Hansen, who for decades has been a guiding light for the Sagebrush Chapter of the Studebaker Drivers Club. He unselfishly devoted his time and resources to helping the Studebaker cause and his fellow Studebaker drivers. We lost this great human being to cancer in September 2004, but we will always remember his many contributions and love of life.

The Harold Hansen Memorial Lake Tahoe Challenge Tour is the driving event for the 2005 Pacific Southwest Zone Meet and a challenge to your Studebaker's mechanical fitness and your ability to handle it on a road course designed to test you to the highest exacting standards of mechanical prowess and safety with a particular emphasis on safety. This course, which is just shy of one hundred and fifty miles, covers the Interstate Highway system, Nevada and California state highways and lesser narrow paved thoroughfares. There is a twenty minute rest for you and your Studebaker as well as water for both in the morning and in the afternoon, and an hour lunch layover near the beach in historic Camp Richardson, California. You are encouraged to have a navigator and you are welcome to switch driving responsibilities as you wish. You may bring as many passengers as comfortably fit into your Studebaker. Detailed

maps and an explicit written guide will be provided as well as verbal instruction at the **Tour Breakfast at 7:00 AM, Friday, September 9, 2005** at the **Boomtown Hotel Resort**.

There is no entry fee for the Harold Hansen Memorial Lake Tahoe Challenge Tour, but you need to indicate on your registration form that you will be with us on the tour so we can plan lunch with reasonable accuracy and prepare your award.

No Studebaker driver will take for granted that the old Stude can make a challenging journey without a serious safety check and necessary repairs and upgrades. The electrical system will be very important to you on this tour. Needless to say, the braking capabilities are paramount. A significant decline from near nine thousand feet, for example, will require the system to be in top notch condition. Steep inclines will test your engine as well as cooling system. The course is designed to put your suspension system to work so ensure it is healthy. An optional, alternate route of the same length is available for Studebakers qualifying for Antique Studebaker Club status.

Although we hope not, there always exists the possibility of a breakdown on such a tour, a certified Studebaker mechanic with tools will be on the sweep vehicle. Not required, but it would be well if each entry were equipped with a cellular telephone.

Included in the tour is the **High Sierra Poker Run** with cards dealt at Boomtown at the tour breakfast, the Mount Rose Summit rest stop, the Camp Richardson lunch stop, the Kings Beach pit stop and the Truckee, California Show and Shine at the railroad depot.

Also, you will want to enter the **Chevron Gas Economy Run** on the Tour. Simply fill up your Studebaker before 9:00 AM, Friday, September 9th at Boomtown Chevron at the resort, stay on the prescribed route making all the checkpoints, fill up at Boomtown Chevron prior to 9:00 PM, Friday, September 9th and give your receipt to the economy run official in attendance. Awards for up to four cylinders, sixes and eights will be given at the awards banquet. Each participating Studebaker must be registered in the 2005 Pacific Southwest Zone Meet.

NOTE: It goes without saying, the **Tour Breakfast** at the hotel, **7:00 AM, Friday, 9 September 2005** is necessary to gain the information for the Tour and get registered for awards. The primary key to a successful tour is everyone being on the same page, so don't be late for breakfast.

"The Buddy Holly Story" show features over twenty of Buddy's greatest hits and received a rave review from Kyle Lawson in the 4/22/05 Arizona Republic (read the review below). Be there or be square.

'Buddy Holly' a rocking, moving revue

They were in their 60s, their 30s, their teens, and they were on their feet, clapping to the same beat, dancing to the same music. It was a rare sight in Valley theater, but it's commonplace at performances of Buddy: The Buddy Holly Story at Broadway Palm Dinner Theatre.

Tuesday's audience couldn't resist the challenge of the cast to "rock and roll," and they filled the aisles of the Mesa theater during the final moments of the musical tribute to the singer who died in a 1959 plane crash. And how could they not? The music had been irresistible from the start. Maybe Baby, Peggy Sue, It Doesn't Matter Anymore, Oh, Boy, That'll Be the Day . . . the very names of the songs give the feet an itch to move.

Buddy is that rarity, a musical revue that actually has a story to tell. Holly's life was the stuff of drama, and Alan Janes' script makes the most of the singer's meteoric rise to fame, his stubborn fight to do things his way, his precipitous marriage and the breakup with his longtime band, the Crickets, on the eve of his death at the age of 22.

The show re-creates two memorable concerts: the Crickets' appearance at the Apollo Theatre, when they were the first White act to ever play the Harlem landmark; and the February 1959 gig in Clear Lake, Iowa, in which Holly, Ritchie Valens (La Bamba) and the Big Bopper (Chantilly Lace) took to the stage to sing their hits just before boarding the doomed plane.

There were unabashed tears in the audience as that final concert drew to a close Tuesday. The Broadway Palm cast made the folks out front care about the characters they were playing. Knowing these people's fate was heart-breaking, but the music was so overwhelming that everyone kept on dancing.

If for no other reason, see this one for its lead performance. Billy McGuigan, decked out in broad-rimmed glasses and thin-lapelled '50s jackets, doesn't just portray Holly, he is Holly. He has the voice, the mannerisms and the personality down to the last leg kick and guitar flourish. Yet, for all the fireworks, he takes your breath away when he sings one of Holly's most beautiful songs, True Love Ways, accompanying himself on acoustic guitar.

Everyone in this cast plays their own instruments, whether it's Anthony Rand (bass), Matt Hinkley (guitar) and Jason Rosoff (drums), as the Crickets; or Joe Clark, Al Fischer, Cindy Rand and others, in their roles as various musicians in Holly's life. They're all wonderful but, even if they just sing - Chuck Caruso's the Big Bopper, Justin Barnum's Valens and the Apollo quartet of Melanie Brookins, Badia Farha, Mitzi Smith and Jim Thomas - they turn every appearance into a show stopper.

When this group rocks, the whole building shakes.

Arizona Emissions Test Exemption for Collectible Vehicles Signed Into Law by Governor By George Wood, AAHC Webmaster

A bill (H.B. 2357) to exempt qualified collectible vehicles 15 years old and older from the state's mandatory emissions inspection and maintenance program has been signed into law by Arizona Governor Janet Napolitano. Under the new law, qualifying vehicles would have to maintain appropriate collectible or classic automobile insurance to retain these benefits.

The new law:

Defines collectible vehicles as 15 years old or older, OR of unique or rare design, of limited production and an object of curiosity and maintained primarily for car club activities, exhibitions, parades, etc. and is used infrequently for other purposes.

Provides for a rolling 15-year emissions inspection exemption that would exempt qualifying vehicles upon enactment and would pick up an additional model year for each year the law is in effect.

Provides for an emissions inspection exemption for collectible vehicles for which the owner holds appropriate insurance coverage.

Acknowledges the relatively minimal environmental impact of older vehicles, such as the older vehicles targeted for this exemption.

Recognizes that such vehicles constitute a small portion of the vehicle fleet and are well-maintained and infrequently operated.

Congratulations to all of the Arizona hobbyists whose hard work and perseverance made this new law a reality.

Editor's Note: We must now wait until the EPA approves Arizona DEQ's request to exempt our vehicles from their "SIP" or "State Implementation Plan" to improve the state's air quality.

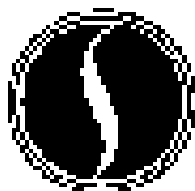
TECH TIP BY LARRY CUSHING

It's summer in Arizona and your Stude is going to have to contend with some REAL HEAT.

If your fan belts and radiator hoses are more than 2 years old, they should be replaced even if they seem to be good. After replacement, put the old belts & hoses (if they appear serviceable) in a box in the trunk, with a couple of gallons of distilled water, to use as spares. The new one's may go sour while on the road and some spares will save your outing.

Always use distilled water in your radiator and name brand anti-freeze. While doing all this cooling related work it wouldn't be a miss to flush out your radiator and engine block.

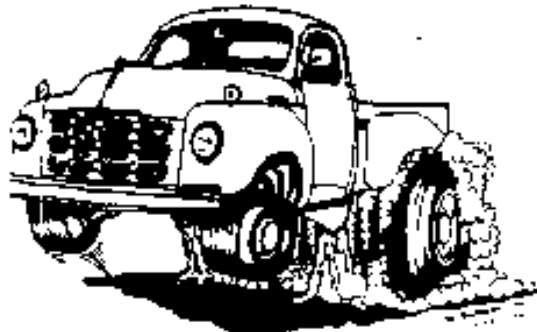
