SOUTH BEND MEET 2006 BY CHRIS COLLINS

Saturday morning, we made a quick trip to SASCO to say hi to vendors we knew and then went on to the fairgrounds for a busy day vending and catching up with old friends and meeting new acquaintances. The local chapter held the car show on Saturday and other marques were shown along with a nice array of Studebakers. Both days the chapter members were kept busy at the Starlite Cafe serving sweet rolls and coffee during the morning hours and dishing up barbecue and Hawk dogs for the lunch crowd.

That evening we joined several prom couples from local high schools for dinner at Tippicanoe Place, Clement Studebaker's former mansion and now a restaurant.

All of the drivers were awarded prizes commensurate with their effort and placement. The white elephant prizes were donated by members of your Board of Directors. It was a little warm but that simply added to the challenge of the race. If it was easy, everybody would do it.

A brief review of the race rules for you if you are planning on racing.

1. Vehicles must be Studebakers or one of the marks manufactured by them, this could include certain makes of tractors.
2. Vehicles are to be driven in a forward gear.
3. The engine must keep running, if it stalls, you will be disqualified.
4. No brakes, either foot or emergency, may be used to slow the vehicle during the race.
5. The clock starts when your vehicle begins moving and crosses the start line.
6. Once the vehicle starts to move, it may not stop until the front bumper has crossed the finish line.
7. The clutch on manual transmissions must be out and left alone during the race.
8. There is no limit to the number of people that can be placed in a racing vehicle.
9. There is no limit on the size of your Studebaker.
10. There is no limit on the number of transmissions your Studebaker may have.
11. Prior to the race the engine idle speed may be adjusted.
12. The length of the course, uphill or down, curves etc. are up to the discretion of the Chief Race Judge who will often times be the same as the meeting host.

The racers and the race fans watching from the shade of the restaurant had a good time. You can see photos and additional highlights later in this issue of the Echo.

Hot Dog! we have a web-master in training! Linda Saar has stepped up to the key board and volunteered. Chuck Collins agreed to train her on the finer points of web master techniques. Thank you Linda for volunteering and thank you Chuck for your many years of service and your continued commitment to help Linda become proficient in her new duties.

TECH TIP OFFERED BY STEVE FEIN

When it is necessary to make a Gasket for a Body or Trim Part (or any other part) try the following.

- 1) Take a piece of the gasket material a little larger than you need.
- 2) Cut holes in it for the mounting screws so that you can Bolt/Screw it between the two parts.
- 3) Tighten the screws and leave it for 24 hours.
- 4) Cut out the gasket on the newly embossed marks made by the trim piece.

This is more accurate than tracing the trim part and is also easier to do.
I have used this method on a taillight assembly & an exterior mirror and it works great.

CORRECT USE OF SDC'S THREE TRADEMARKS BY LARRY SWANSON SDC'S NEW TRADEMARK ADMINISTRATOR

Larry Swanson, SDC's new trademark administrator, has sent the Chapters a letter outlining the use of SDC's three trademarks - the words "Studebaker Drivers Club", "Turning Wheels" and the wheel artwork with "Studebaker Drivers Club" inside.

Larry writes, "Federal trademark law requires that to protect our trademark rights SDC must keep records of how each trademark is being used.Both SDC Chapters and individual members have the right, with some restrictions, to use it on business card and stationery. When it is used on any item sold for money, such as jacket patches or novelty items, you must have a permission letter from SDC. As the new trademark administrator, I assume that those projects already in production already have permission letters. However, if you do not, or if your original permission letter has been lost over the years, for the protection of both sides, just write or email me for a new one.

"Some trademark owners require that you send them one of each item that you are producing so they have a sample of every use in their inventory. We do not have the storage facilities to keep such a large collection of items which would accumulate if we asked you for samples. However, we do ask you to send us a photo by fax or email of each item. On each item please identify what individual member or chapter is producing that item. The SDC will have a master record which should satisfy any legal requirements and still fit in a small filing cabinet."

Attached to Larry's letter were the following guidelines.

The SDC logos are registered trademarks and may not be used by any individual or business entity without express written permission of the Studebaker Drivers Club. Exception - that a member in good standing may display either in order to so identify himself, such as a calling card or personal stationery or club decals.

If a member offers goods or services, the logo must have "member" directly under the logo. Wording on the advertisement or calling card should not imply the club endorsement of goods or services.

Chapters have the right to the SDC trademark to identify their chapter affiliation or combine with chapter name or chapter logo.

If a chapter uses the SDC logo on any fund raising project or otherwise, they must apply for permission by sending in a short statement of usage and purpose to the trade mark administrator. Written permission will then be given.

When a violation has been found the trade mark administrator will notify the violator to cease. If the violator is a chapter or member, then a notice will be sent requesting a letter asking for permission.

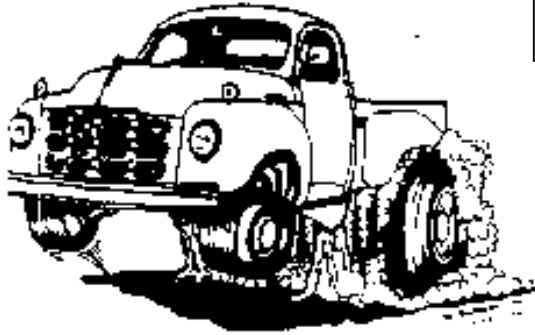
