## 1962 LARK PHOENIX POLICE CAR



This 1962 Lark Phoenix Police Car made its official debut at the Cops and Cruisers Car Show held at the Wesley Bolin Memorial Plaza in downtown Phoenix on November 23rd.

The Lark was found at Chuck Naugle's Stude Acres in very poor condition but with the skillful efforts of Will Eastburn the Lark has been restored to its like-original condition.



## TECHNICAL INFORMATION .....

### Home Made Tools

I have been cleaning up a number of cylinder heads and blocks lately. You know that caked on crud you see in the cooling passages inside the head or block (mostly rust) and you can't quite figure out how to get to it. Well, I might have just the tool for that, and it's home made.

I use wire cable and turn it into a flexible wire brush. There is only two parts to making this tool, wire cable and copper tubing, and a crimping tool. I use a co-ax cable crimper. The key is matching wire and tubing so the wire just fits inside the tubing. Then any diameter wire can be used to make this tool to fit the job at hand. I have made them as big as 3/8" wire cable. My favorite is 3/16" wire and 1/4" copper tube. Cut wire to desired length (12" to 18" works for me). Cut three pieces of tubing at 6", 1" and 1/2". Slide the 6" piece on first, this is the handle. At one end of the cable, take the 1" piece and crimp this to the cable - this end is captured in the drill chuck and prevents the cable from unraveling during use. At the other end, slip the 1/2" piece about 1" to 1-1/2" up from the end, crimp this to the cable. Using two pair of pliers, unravel and bend back the cable strands till it resembles a wire brush. Chuck it up in your hand drill and you're ready to go, BUT! YOU MUST RUN YOUR DRILL IN REVERSE. This is because most cable is assembled in a right hand lay'. If the brush end of the cable gets wedged and stops turning the drill will keep turning the cable and open up the lay and render your new tool useless.

## NEWS from the ADOT MVD

### **LICENSE PLATES, TABS AND DOCS NOW COMING THROUGH THE MAIL**

The new year will usher in a new way for customers to get license plates, registration tabs and many documents such as vehicle titles.

Beginning in January, customers will receive these items through the U.S. Mail and will no longer be able to obtain them at an MVD or Authorized Third Party office.

All registration documents and license plate tabs, including those issued today at MVD self-service kiosks, will be mailed. When customers renew, their record is updated instantly and a receipt will be proof of registration.

For customers getting a license plate, the change will also mean the plate number will be entered into the customer's service file and the temporary plate issued at the office will have the same number as the permanent plate being mailed.

Customers who purchase Off-Highway Vehicle decals the same day they plan to use them at a recreational area will not receive the decal at the office, but will get a receipt that should be kept with them to prove the decals have been purchased.

In the future, more vehicle titles will transition to an electronic process. Currently, a limited number of title transfers such as one-owner to one-owner transfers of Arizona-registered vehicles can already be done entirely online through AZ MVD Now, which is available through ServiceArizona.com.

### **GET THE AZ TRAVEL ID**

Now is a great time to consider getting your AZ Travel ID. Make an appointment at [www.servicearizona.com](http://www.servicearizona.com), or drop in. Also, many Authorized Third Party providers offer the AZ Travel ID. For information on hours and locations, go here: <https://azdot.gov/motor-vehicles/mvd-hours-and-locations>.

Remember, on Oct. 1, 2020, new federal ID rules take effect at airport security checkpoints. The AZ Travel ID is the easiest and most cost-effective ID that will get you through TSA security so you don't miss your flight. 

## CARGO WAGONS

Most of the horse-drawn wagons built in the United States during the early 19th century were produced slowly and in varying quality by small concerns that were often one-man operations. The nation's westward surge from the 1840s onward changed all that. Scores of companies sprang up to supply vehicles for the transport of people and goods beyond the Missouri. Some firms even boasted of specialties; Peter Schuttler of Chicago, for example, made wagons that could be coupled together. However, Schuttler's output never matched that of the wagon industry's two giants: the J. Murphy Company of St. Louis and the Studebaker Brothers Manufacturing company of South Bend, Indiana.

Studebaker featured an extensive line of vehicles ranging from ambulances for the military to carriages for the gentry. For both companies, however, freight wagons were the staple product, as meticulously crafted as the most glittery surrey. Irish-born Joseph Murphy would not allow his workmen to use augurs to bore holes when they had to bolt planks together; instead they burned the holes through with red-hot irons to keep the surrounding wood from cracking or rotting. John, Clem and Peter Studebaker enforced equally high standards. They aged the hardwoods in their wagons for a period of three to five years to prevent shrinkage in the dry Western climate, and they had their black hickory axles boiled in oil to drive out moisture. For all the perfectionism, the cost of most freight wagons was held to less than \$200 by quantity production. By 1874 the 50 workers at the Studebaker brothers' plant, with the help of a steam-powered production line, were turning out more than 30 wagons a day.

Like Joseph Murphy, the Studebakers were able to retire as millionaires. The brothers had the added pleasure of seeing their enterprise chalk up a record as the largest of its kind in the world - producer of a total of three quarters of a million wagons.


